Monthly Executive Report as of June 2016

# I. Market Value as of June, 2016

The market value of the Economic and Social Stabilization Fund (ESSF) totaled US\$14,603.46 million as of June of 2016. The market value changed during this month due to: (i) accrued interest of US\$14.85 million, (ii) capital losses on investments of US\$420.14 million and (iii) administrative, custody and others costs of US\$ 0.33 million.



## II. Return as of June 2016

Return in US dollars was 2.99% in June. This was mainly due to the performance of Money Market and Sovereign Bonds, 3.34%, and Sovereign Inflation Linked Bonds, 1.29%. By month-end these portfolios represented 89.2%, and 3.5% of the fund, respectively. The performance of Equity portfolio in US dollars was -0.53% and represented 7.3% of the fund. Money Market and Sovereign Bonds portfolio monthly return in US dollars was mainly explained by currencies' appreciation against the US dollar and by the performance, in local currency, of the nominal bonds of the portfolio. Sovereign Inflation Indexed Bonds portfolio return was positive both in US dollars and local currency. The return of the fund in pesos was -1.18% in June mostly explained by a 4.17% depreciation of the US the dollar relative to the peso. Year to date return was 7.89% in US dollars and 1.40% in pesos, while annualized return since inception was 3.01% in US dollars and 5.24% in pesos.

Returns for periods of more than one year are compound annualized rates while those for less than a year correspond to the change as seen in the stated period. With a view to meeting high standards of transparency and providing a better assessment of the gains or losses on investments, the Ministry of Finance discloses the fund's return in different time horizons and currencies. With respect to the horizon, it is important to note that, in keeping with the medium- and long-term investment policy, the return assessment should focus on that period, disregarding fluctuations that may occur monthly or quarterly. With regard to returns expressed in different currencies, the return in US dollars allows for an assessment which is more in line with the investment policy given that the fund's resources are wholly invested abroad and in foreign currency. The return in Chilean pesos is also disclosed. This return reflects changes in the peso-dollar exchange rate and, therefore, may experience greater fluctuations. Finally, as with any investment, returns obtained in the past do not guarantee future positive results.
